

GYM USE AGREEMENT

Peak Athletics Plus offers the use of this athletic training facility with the following stipulations and requirements:

1. All athletes must be under the age of 21
2. All athletes must sign a *Liability Release Form* that will be kept on file at Peak Athletics Plus.
3. The Team Coach or School Administrator must maintain an accurate roster of athletes practicing in this facility, and ensure compliance on all policies
4. The Team Coach or School Administrator must provide either a valid blanket Purchase Order or must contract in writing for payment of tuition.
5. The Team Coach or School Administrator must provide full contact information for the responsible party, as well as for a secondary contact (page 2 – this form).
6. The Team Coach or School Administrator must [provide a contact point at the school in the event that PEAK needs to resolve any financial matter (page 2 – this form).
7. The Team Coach or School Administrator must be able to sign a General Liability Waiver releasing Peak Athletics Plus from liability for student athlete or coach injury (page 2 – this form).
8. The Team Coach or School Administrator must be able to provide a Proof of Insurance certificate that will be kept on file at Peak Athletics Plus.

Proper Attire: We require that our athletes and visitors to the *Peak Athletics Plus* gym be properly attired for their sport and situation. We reserve the right to ask anyone to leave if clothing is considered inappropriate for this youth-oriented setting. Cheerleaders need to wear tennis shoes, shorts or pants without pockets that must cover seat, and t-shirt that must cover mid section. Gymnasts must wear a leotard, or shorts and t-shirt that must cover mid section. Strapless tops, midriff or crop-tops and spaghetti-strap tops and blue jeans are not allowed for athletes without specific approval from management. At no time will excessively revealing attire be allowed in the facility. Logos or graphics that are sexual, offensive or vulgar will not be allowed in the facility.

Parking: We must ask that all visitors and staff at *Peak Athletics Plus* park in the designated places in our lot only. Do not park in the lot for our neighboring businesses (*24 Hour Fitness* or *Highlands Ranch Learning Center*) or on the street unless you are specifically authorized to do so. *Peak Athletics Plus* will not accept responsibility for tickets or towing fees for improperly parked vehicles. Vehicles parked in fire lanes, in an improper manner or by parties not attending class at *Peak Athletics Plus* may be towed at the owner's expense.

Timeliness: Each team has a specific practice schedule that must be maintained. Cancellations to practice times must be called in to your designated contact not later than 24 hours in advance. As this facility operates at maximum capacity, at no time may your practice time be extended without prior written arrangement with the Cheer Director or Operations Manager. Teams must vacate the gym floor within 5 minutes of their scheduled time, and must clear the parking lot immediately. Team meetings are not allowed except in the scheduled time on the practice floor.

Food in the Gym: In an effort to comply with health regulations and for the benefit and safety of our student/athletes, we must require that **NO FOOD OR DRINK** be consumed inside the gym or on our observation deck. Our coaches, who may spend an extended portion of their day here, are allowed water bottles, but no other food or drink is permitted. There is a coffee shop and lounge area where food is permitted, as well as in the Dance observation area.

This is not an exhaustive list of Peak Athletics Plus' policies and practices, but is intended to clarify common points of confusion. Please ask your contact point at Peak to help with any questions.
